In continuation to this office Circular No.HC-11/136/2023-24/2205 (3/Haj-2024) dated 8th January, 2024, it has been decided to conduct two days physical Orientation/Training of Trainers Programme on 3rd & 4th March, 2024 at Weight-Lifting Auditorium, Jawaharlal Nehru Stadium, Lodhi Road, New Delhi – 110 003.

The registration will start at **08.00 a.m.** on **3rd March**, **2024.** Participants to occupy their seats by **08.30 a.m. till 08.45 a.m.** The programme shall start from **09.00 a.m.** All participants should remain present in the Inauguration session. The trainers have to arrange their return journey only after completion of final training session at 06.30 p.m. on 4th March, 2024. The trainers are advised to attend all sessions of training.

2. The SHCs should give wide publicity detailing the date, time and venue of Training sessions to be conducted in each district, alongwith the name and mobile numbers of Trainers. SHCs shall render all possible assistance to the Trainers in organizing the Training Camps at District/Taluka levels in all matters. All such details be made available to HCoI as enumerated in Circular No.HC-11/136/2023-24/2205 (3/Haj-2024) dated 8th January, 2024.

3. T.A./Honorarium to the eligible Trainers will be paid through RTGS in their given bank account only. All the selected Trainers are advised to fill up the T.A./Honorarium Form alongwith the copy of to & fro journey tickets and submit the same to HCoI at the time of Training (format available at Annexure-IV of Circular No.HC-11/136/2023-24/2205 (3/Haj-2024) dated 8th January, 2024.
