Subject: Release of Waiting List for Haj- 2023.

As on date, 8553 Haj seats have become available due to cancellations received from various States. A statement showing cancellations received from the respective States and the wait-listed pilgrims for Haj-2023, who are now provisionally selected in terms of Guidelines for Haj-2023 is **Annexed**.

2. The aforesaid provisionally selected pilgrims are required to deposit full Haj Amount of respective Embarkation Points (as per Circular No.13 dated 06.05.2023).
3. Payments can be made either,
 - a. Online at <http://hajcommittee.gov.in> or
 - b. In Haj Committee of India account maintained with SBI or account maintained with UBI through any branch of SBI/UBI having core Banking System by using unique Bank Reference Number in the Specified Pay-in-slip on website.
 - c. By cheque of any branch of SBI/UBI in favour of the respective Bank.
4. These provisionally selected pilgrims may be advised that after depositing the amount, they shall submit Pay-in-Slip, Haj Application Form (HAF), Solemn Declaration and Medical Screening & Fitness Certificate (Government Medical Officer/Doctor) alongwith Original International Passport to the concerned State Haj Committee on or before 17.05.2023.
5. The State Haj Committees shall submit the valid machine readable International passports after uploading all documents along with pay-in-slip, Medical Screening and Fitness Certificate to Haj Committee of India on or before 19.05.2023.
